- acknowledged Andrew Lockman's support to manage and improve our website
- noted Board member contributions: Frank Pearce (Vice-President and drafting of new Constitution); Kate Dobson (Secretary and renewing the AGM & Awards format and supporting documentation); Christine Fraser (Treasurer); and Ranald Moore (General Board member) who has recently resigned (relocating to NSW), for his contribution in updating the Board's procedures.
 - New Board members Sarah Williams and Kelsey Timms were welcomed.

NHWT has seen enormous change since its beginnings in 1986 and it has been a year to reflect and recognise the contribution it has made to Tasmania. He hoped all members took pride in their attendance at the AGM, and it was this pride that had resulted in a new policy in 2021 for the awards being presented at the AGM. - Roxley Snare, Central Wynyard reported the group had a reasonably successful year. Even within COVID restrictions impacting their activities and fundraising, they still able to present book vouchers to five local schools, and 16 members were registered in the group. Roxley concurred with Marita's comments, explaining that Police involvement with the Group had been limited, and crime reports were difficult to get.
